FWPA's AGM shows benefits of collaboration

Attended by Senator the Hon Richard Colbeck and a record number of company members and stakeholders, the 2013 FWPA Annual General Meeting was the cornerstone of several events that reflected a growing confidence in the industry.

Held in Sydney on October 11th the 2013 Forest and Wood Products Australia Ltd (FWPA) Annual General Meeting was attended by a record number of FWPA members and stakeholders and Richard Colbeck, Tasmanian Senator and Parliamentary Secretary to the Minister for Agriculture.

Addressing the meeting, FWPA Managing Director Ric Sinclair observed that the company was now 6 years old and had clearly established systems and strong corporate governance. He noted that federal Government funding had been secured for the next 5 years, together with the opportunity to secure matching funds for voluntary contributions.

Mr Sinclair also explained that there had been a realignment of investment priorities, details of which were in the new 5 year strategic plan that had been approved by the Board.

"Our expenditure is now balanced with income and that's led to a 33% reduction in activities. This situation will continue until our levy payers and members are supportive of increased funding for collaborative activities," he said.

The meeting also saw the re-election of Ron Adams and the election of a new independent director, Craig Taylor who is a Director and Principal of The Fifth Estate, a Sydney based consulting firm. Mr Taylor has previously held management and executive roles with the State Forests of NSW, BORAL Timber, Wesfi and Jaakko Pöyry Consulting. He has a BSc (Forestry) from the Australian National University and is currently a Director of P.F. Olsen Australia.

"It is an honour to be voted in as an independent director by FWPA members. I look forward to working with my fellow directors to build upon FWPA's successes and to take the company to the next level," Mr Taylor said.

Mr Sinclair said that all resolutions, including a special resolution to make minor amendments to the Constitution, were supported by the company membership. At a
